1. DEMO QUICKSTART

This Demo version has a few records of sample data, so you can see how most functions work. The Demo version uses QSA Toolwork's Helix Engine demo version, so it may quit after 60 minutes or so and is limited to 30 records per relation. When you purchase Helix Engine, Helix Rade, or Helix Server/Client, QSA will provide you with an Enablement Key and Serial Number; the fully registered versions of Helix do not have the demo limitations. Cudgel requires a Macintosh operating system, currently at least Mac OS 10.5.

- Transfer <Cudgel®45DemoX>, <Helix Engine>, and <Helix Help> to your hard drive. Helix Engine should be v 6.1.7 or later
- Double-click Helix Engine • File menu> Open> Cudgel®DemoX • Login Information> Username> Demo [Leave Password blank] > OK • Demo menu> Welcome to Cudgel®
- Welcome to Cudgel®> Cudgel Topview [Brain button] Shows some of Cudgel's many easy functions. Click on TopView icons if you want to see some views immediately.
- Welcome to Cudgel®> Cudgel Helps You Setup. • Complete reading this ReadMe • Welcome to Cudgel®> Cudgel Topview> Help> Manual

If you want to read part of the Manual. Start with the A- About pages, Then the B-Basic pages. This demo pdf manual is static; once Cudgel is launched in Helix the Cudgel Manual (and associated Help Hints) are dynamic.

Its WhyTime simply structures complex deadline rules of diverse jurisdictions, while Mapper graphically displays clients, matters, cases by jurisdiction. For each matter, readily see the last and next required actions and the responsible staff person. CalendarEye helps to monitor and maintain government registrations of diverse venues from county to country— trademarks, patents, designs, copyrights, customs, FDA, and more.

Client Portrait's **hierarchical design efficiently organizes complex corporate** contacts—personal contacts, secretaries, parent and sibling corporations, subsidiaries, affiliated businesses, partnerships, trusts, name changes, mergers, and acquisitions. With user defined groups, Client Portrait eases firm marketing, identifies potential conflicts of interest, prints multi-lingual form letters, exports to Palm PDA, and provides for Myers Briggs personality descriptions.

Helix relational database environment, published by QSA Toolworks, initially launched in 1984, has grown from early client-server, multi-user versions to its current sophisticated features, with referential integrity and, for the power user, powerful technology with iconic programming; <<http://www.qsatoolworks.com>>. GreenLight provides its non-demo software as open architecture, making available the seven structural icons and 100 programming tiles of the full Helix customization environment.

Cudgel is designed for the sophisticated and user friendly Macintosh (Intel chips) and Helix platforms, and isn't now available for Windows. If calendar, client, or case control is important, Windows users should consider adding a Macintosh Intel computer with Cudgel to their firm. See Apple's Why Switch to a Mac, <www.apple.com/getamac/>. Windows users can also download, and read much of the documentation.

3. DEMO DOWNLOAD AND INSTALLATION

This Cudgel® demonstration package is available online.

Windows users can also download, and read much of the documentation and bonus material. However, to run the Cudgel application requires a Macintosh operating system.

NOTE TO WINDOWS USERS. For several years now, Apple's Macintosh computers have Intel central processing units (CPU or chips) and thus, with a licensed copy of Windows operating system, can run Windows applications as well as the many Macintosh applications. Some reviewers have found Windows applications run better and faster on Macintosh hardware than on conventional PCs.

If you received an optical disk, CR-ROM, from GreenLight, drag the GreenLight folder from the distribution disk icon to your computer's desktop.

Before installing new software, it is prudent to check your hardware and software with a utility program, such as Disk First Aid, Tech Tool Pro, or Disk Warrior. Also ensure you have a good backup on separate media.

Windows users can download the documentation and bonus extras, but need not download Cudgel®45.617-DemoX, Helix Engine Demo, and Helix Help—these applications currently require the Macintosh Operating System (Mac OS 10.6 or higher).

If you already have Helix (at least v 6.1.5) installed on your computer, you may delete the Helix demonstration icons. (If you do not delete the Helix demo icons and double-click Cudgel, your full Helix or the demo Helix program may launch.)

Cudgel@DemoX is limited to 30 records in many critical relations and is time limited; after 30 days from first installation it may intermittently behave erratically. Helix Engine (Demo) is limited and automatically quits after 60 minutes of use—you may restart; the full Helix program is not so limited. The full Cudgel® product does not have these demonstration limits; usage is limited only by your hard drive and the generous Helix specifications.

Standalone, single users will use Helix Engine (or Helix RADE). Multiuser non- demo versions will use Helix Server and Helix Client; Cudgel remains operable as a single user system when the Cudgel collection is not being used by multiuser Helix.

After successful installation, store the GreenLight distribution disk in a secure place. Remember that computers are physical objects subject to error; frequently backup your data on separate media; routinely run your Helix collections through the Helix utilities.

4. EXPLORING THE CUDGEL® DEMONSTRATION SOFTWARE

Under the Demo menu, choose WELCOME TO CUDGEL®. There are several ways to explore Cudgel. • Read the User Manual, especially the About section, for an overview of Cudgel.

- Explore the TopView sequence buttons, which demonstrate over 50 Cudgel views. • Under the Demo menu, choose DEMO_MORE_MENUS, which gives Demo user access to most menus.
- Launch the CaseBook, which shows several common reports used for case management. • Under the Demo menu, choose SETUP PANEL, step-by- step iconic button guides to customization. • Under the Demo menu, choose START, which describes customizing Cudgel for you and your firm. • You can always return to the WELCOME and the TOPVIEW views, under the SET or DEMO menus.

Read the GreenLight Cudgel® Demo License (button on the Welcome view; if the license doesn't appear: View> Find First). Send GreenLight your Feedback (An easy form is under the Demo menu). Order the full Cudgel® software without the Demo limitations (under the Demo menu, choose Yes!)

5. CUDGEL IS A POWERFUL, FLEXIBLE STRUCTURE, NOT A GAME.

Cudgel with CalendarEye and Client Portrait is not a game, it does not do anything by itself; it is not a demo slideshow. Cudgel is a powerful, structured, flexible data environment in which you can place much of the data you encounter and from which you can readily retrieve that data, automatically create intelligent short letters, and gain control over your cases, calendar, and client marketing.

The more you read the Cudgel and Helix manuals, the more you can do, and do more easily. Or just explore with the menus and demo panels; it's only software and sample data.

CudgelDemoX ships with two sample cases and a few sample actors, dates, matters, and the like. Sample actors include Michael Heinlein Smith of Groking Endeavors, Robin Clark Kent, Daniel Webster II, Otto Schmink, Adolph Entropy, Magistrate Solomon; the two sample cases are Alpha Centuri v Zed Co and Alpha Centuri v Havoc Enterprises.

WARNING. The data that ship with Cudgel may be fictitious and/or out of date. Do not rely on any of the data (from address, phone number to case holding or citation) initially included; it is provided only as a tutorial within Cudgel.

GreenLight's products are user-friendly, open architecture. However, if you don't want to bother with setting up the software for your particular use (inserting your firm name, defining the major areas of your practice, building a library

of form letter scripts) diverse consultants can assist you: Elan Associates, Helix developers, and others. With current phone and Internet communication, your consultant need not be geographically close. While consultants are available, GreenLight generally recommends users read the Cudgel manual, follow the Start guide, start with the major simple functions, and expand as comfort and need suggest.

The Welcome to Cudgel® Demo view presents **five ways to explore Cudgel. First**, Cudgel Topview shows over fifty features grouped in five categories: CalendarEye, Client Portrait, Cudgel, Cadence, and Help. We suggest you interact with Cudgel, simulate getting a new client and case, and

add some of your own data.

Second, the Warning and Icon Symbols view displays fifty common icons keyed to upcoming deadlines, client issues, statutes of limitations, and data posting.

Third, the Online User Manual describes Cudgel operation in 26 chapters.

Fourth, CaseBook shows common reports for a case— CaseBooklet shows Case Actors, Billings, Cites & Lines, Dates Marker, Exhibits, Papers, and VTabs; CaseBook opens 25 views.

Fifth, explore the Cudgel Start (textual description) and Setup Panels (29 icon- guided steps to set up your Own Firm, Actors, Work, Customize, Files & Cases.

The **Demo User** is provided for demonstration versions of Cudgel. Choose DemoMoreMenus and then Demo User's menus expand to almost all the commands of the fully licensed Cudgel program, but with severely restricted access privileges. The Demo User often cannot print, and cannot export or import data. Demo user may delete records only from some views. In addition, the Demo User is limited to no more than 30 records of data per most relations; thereafter the demo misbehaves erratically. The Demo User is also limited in time; beyond the given time limit, the demo misbehaves erratically. Because of some use protection in the demo, it may perform slightly slower than regular Cudgel. The Demo User can print the Feedback form for GreenLight, and can print an order form to purchase Cudgel (the Yes! command under the Demo menu).

DemoFixer, under the Demo menu of Demo user, presents menu choices that customize Cudgel for your firm: form letter scripts, abbreviation, interest rates, case tabs, quotes, matter statuses, treaties, firm organizational units, venues, deadline rules, zones, customized help hints, proof standards, and commands to make powerful changes—new client, new owner, new staff, close case, close client.

Cudgel helps you work your way, with your clients, cases, and matters. You can start productively using Cudgel with only a few clients, matters, and scripts. As you continue to transfer your firm's data into Cudgel you'll gain the fast, flexible, friendly power of a relational database and the efficiency of Cudgel. «

- **Demo Version.** Cudgel®DemoX users may explore Cudgel® with CalendarEye®, Client Portrait®, and Cadence® to determine whether they wish to purchase Cudgel and may install the Cudgel®DemoX version on their computers. Cudgel®DemoX users may not reverse engineer or otherwise illegally simulate the organization, structure, or function of GreenLight software. Moreover, Cudgel is patented, as well as protected by copyright and trademark law. This agreement does not grant you any ownership right in or to the Software's intellectual property.
